Regular Meeting June 21, 2011

Present: Ms. Schulda, Mr. Bosma, Mr. Pancost.

Chairman Pancost opened the meeting with the reading of the minutes of the June 7, 2011 meeting which were approved with one correction.

Chairman Pancost recognized Ms. Diane Rohde. Ms Rodhe was administered the oath of office for the position of Fiscal Officer, Hiram Township, beginning July 1, 2011.

Mrs. Janet Pancost was recognized. Mrs. Pancost asked if Mr. Schrader, the Townships attorney, will be in attendance tonight. He is expected to be here and will answer questions regarding the annexation court action later tonight.

Hiram Fire Chief Bill Byers gave the Board an update on the safety forces activities for the last month. Chief Byers said the new fire department pickup truck will be built soon.

Old Business – Ms. Schulda said the attorney for Hiram Village has not scheduled a meeting yet on the 2% income tax issue. Ms. Schulda said that Mr. Steiner of Portage Solid Waste Management will has trash bids go out within six weeks and all interested parties will be notified at that time. Ms. Schulda attended a waste water meeting. Instillation of rain barrels was discussed and encouraged but little else of importance was covered.

New Business – Ms. Schulda will attend the summer conference of the Ohio Township Association. A meeting of the Northern Ohio Township Association will be held in Ashtabula soon.

Mr.Pancost said the Township has 48 ½ hours of time left at Portage Planning for this year.

Zoning report – Mr. Garey found an accessory building on Allyn Road being built without a permit. Mr. Garey will get a legal opinion about the roof lines on accessory buildings from the County Prosecutor.

Roads Report – Mr. Matota and crew have been doing overlay work in preparation for chip and seal work. Ditch maintence is being done on north Udhall Road. Recent storms have caused damage to drainage. The new pickup truck is in and will be delivered soon. The backhoe has been getting repaired but some problems still exist. Electric work at the garage has been completed.

Chairman Pancost recognized Mr. Al Schrader, Attorney for the Township. Mrs. Pancost asked him about the annexation court action and the appeal filed by the Village and Hiram College.

Ms. Schulda called for an executive session to discuss pending legal litigation issues. Mr. Bosma seconded the motion. Roll call vote: Mr. Pancost AYE, Ms. Schulda AYE, and Mr. Bosma AYE. The Board went into session at 7:35 P.M.
