Regular Meeting Minutes October 2, 2012 7:00 PM

Present: Chairman Groselle, Steve Pancost, Kathy Schulda

Chairman Groselle opened the meeting with the Pledge of Allegiance and the reading of the September 18, 2012 minutes. Steve Pancost motioned to approve the minutes as corrected. Kathy Schulda seconded the motion. Roll Call Vote: Groselle AYE, Pancost AYE, Schulda AYE. The minutes were approved.

Josh Johnston gave a presentation concerning our website and him wanting to bid on it starting January 1, 2013. He will be getting more information to us regarding this.

It was asked to post the Forestry Plan on the web site. That will be done soon and the Comprehensive Plan will be posted too.

Charles Patterson, who owns 12877 Thrasher/Rapids Road, said he will get a plan together concerning his property and present it at the next meeting. His family has had and continues to have health issues that he is dealing with.

Diane Roade said thank you very much for all the support of her son and his competing at the London Olympics. The signs were deeply appreciated.

Fire Report: Chief said all is "OK". The Halloween Party will be October 31 at 7:00 PM. They have also sent two trucks for maintenance.

Old Business: Steve said that the Forestry Plan is open for public comment.

Kathy said that the grant has been approved to help townships with abandoned houses. The Regional Planning Commission will be managing the \$500,000.

The contract to paint the building will need to be done again. The Company has decided not to do the work. Jack will be checking with someone else to do the work on the Town Hall Building.

Chris Merduri has not talked to Hiram Village yet about the income tax.

Chris will also go to court to try to get the suit concerning the 12955 Thrasher/Rapids Road dismissed.

Jack has talked to the people at the Soil and Water Conservation Office again about a letter concerning dealing with the beavers. The trappers will be getting written permission to trap beavers and will start in January, 2013.

The solid waste plan was discussed and concerns are being voiced that the plan needs to include wording so it can go to private companies. A meeting will be held at Maplewood JVS on October 11 at 6:30 to discuss this issue and any others concerning updating the plan.

Jack has been told that the deep well to be drilled by Gary Booklover's property will be coming in off St. Rt. 700 instead of Udall Road.

New Business: Kathy asked that any income be reported at the meeting. That will be done from now on.

Jack asked why the Farmland Preservation renewals are coming to us and not to Soil and Water Conservation. Rich said he had returned one. Jack will e-mail the State to have all renewals go to the Soil and Water Conservation Office.

Zoning Report: Rich has sent a letter to Cynthia Sanderson concerning storing of vehicles on the property. He has talked to people who own property on Cadek Rd. concerning a lot split. It was agreed that they will need to go to the Board of Zoning Appeals to see if they would allow it. He also drove 43 miles throughout the Township to check on compliance.

Road Report: Tom said they will be replacing tires on a pickup soon. He has been pricing and was asked to let Rich Gano submit a price too. Repairs to the 2004 Dump truck will be about \$1300.00 and replacing some parts on the 595 cutting each will run about \$550. A welding shop will help put this back together at a cost of about \$400.00 to 450.00. The 595 will also need 2 tires this winter. This will run around \$1000.00. He will also look at the wash out in a ditch in Rolling Meadows to see what can be done.

Kathy motioned to pay the bills. Steve seconded the motion. By voice vote the motion was approved and the following bills where paid.
