Fiscal Officer:

 Building Generator for the new Facility after the budget meeting.
- Working on getting online access regarding ARPA reporting of funds.
- Spectrum Business Internet to 6352 SR 82 200MBps \$50+tax / month for first 12 months, \$65+tax thereafter (no contract).
- Windstream Kinetic to 6352 SR 82 50MBps \$65+tax / month for first 24 months
- Need to call Verizon for Cell Repeater once the facility gets High Speed Internet.
- **Resolution 2022-008**: Use Spectrum Internet to provide Internet Access to the new Facility (Ms. Blake motioned, Mr. Pancost seconded the motion. Roll Call Vote on the Motion: All Ayes.)

Old Business:

Mr. Pancost stated that the Township received clarity regarding 'cash-in-leu' regarding health insurance of employees after reviewing with the Portage County Prosecutor and the Township's Insurance

Administrator. Mr. Pancost will provide Mr. Hankinson with the necessary paperwork to become a resolution at an upcoming meeting.

New Business:

The metal sign of the property at 6352 State Route 82 has been ordered by Mr. Pancost.

The Township Hall at 11616 Garfield Rd is up for sale. The neighbors were offered the property and both passed on it. Mr. Groselle suggested using the services of Brant Jessel, a Realtor, to sell the property.

Ms. Blake mentioned that the Kent Fire Station will hold an Open House and is looking for speakers. This prompted her to think about hosting an Open House for the new Township Facility some time during the summer. Ms. Blake will propose some ideas at the next meeting.

Mr. Groselle is still receiving calls regarding calls about trash pickup on Herr Drive. A discussion regarding overnight street parking within the Township then commenced.

Mr. Pancost has some grants that he is taking a look at if they will benefit the Township.

Mr. Groselle will discuss with Hal Stamm about finishing the floor in the meeting room area to be less slick. Possibilities include etching the cement floor, or installing exterior carpet squares that are easily replaceable.

Road: Mr. Matota mentioned that the fence at the Rapids baseball field has been repaired. The 420 tons of salt purchased for last winter totaled about \$19,000. The Township pickup needs new tires. Mantua Hardware received the new mower for the Township and it will be picked up. Letters were submitted to the County Engineer but no response yet. The electrical circuits in the new facility were corrected to provide 60 amps for the welders used by the Road Crew.

Fire: Chief Byers supplied a copy of the March 2022 Fire Report and gave some additional updates on their equipment. Also discussion regarding wanting more members of the Fire Department. There are still issues with the Rt 82 Siren. New squad vehicle still progressing, a number for the vehicle has been assigned.

Police: A report for March 2022 was provided to the Trustees.

Zoning: Nothing to report.
