Mr. Groselle asked Mrs. Svonavec how much would the RCCA save if they did not carry insurance. Mrs. Svonavec said she did not know what their insurance premium was but would look into it. Mrs. Svonavec asked the Trustees for a copy of the OTARMA policy which Mr. Hankinson will provide to her. She will then give that to the RCCA Treasurer in order to compare with their insurance policy to see if it makes sense to drop their policy.

Ms. Blake asked Mrs. Svonavec when their Christmas event will be. Mrs. Svonavec stated that there is no event planned. Ms. Blake clarified that the reason she asked is that the Port-a-Pot at the Rapids Church is usually picked up after the Christmas event.
